## *Auto Repair Release Agreement*

Moreover, I assume the potential risks and liabilities associated with having AGR conduct those repairs on the Premises, regardless of whether the resulting damage is to property (real or personal), person, or otherwise. I hereby expressly waive any right to sue AGR for any potential damages incurred in connection with the aforementioned repairs, except for those claims against AGR arising out of its own negligence. I hereby acknowledge the fact that I am at least Eighteen (18) years of age and the record owner of the Premises. I hereby further acknowledge that I have full binding authority to consent to the vehicle repairs being conducted on the Premises.

In accordance with the above-paragraph, by setting my initials on the respective lines, I hereby further acknowledge that I expressly waive all potential claims against AGR for any damages arising from the acts and/or omissions of AGR, including, but not limited to, those items set forth below, and accordingly take full responsibility for ensuring full compliance with these terms:

\_\_\_\_\_ I acknowledge and express my permission for AGR to park and use heavy equipment on the Premises, including but not limited to utilizing my driveway, garage, or lawn, and I further acknowledge that damages may occur to the Premises as a result of same, for which AGR shall not be liable.

\_\_\_\_\_ I acknowledge full and complete understanding that there exists a risk of oil and/or other chemicals coming into contact with the Premises, including but not limited to my driveway, lawn, garage and/or any other personal property, and I further acknowledge that damages may result to same, for which AGR shall not be liable.

\_\_\_\_\_ I acknowledge my own responsibility for keeping all children, pets, family members and invitees away from the vehicle at all times during the repair in order to avoid the potential of personal injury.

\_\_\_\_\_ I acknowledge that damage to property, real or personal, including, but not limited to, my driveway, landscaping, home, and/or personal injury, may occur, and that I expressly take responsibility for ensuring against any such damages where reasonable and practical, and otherwise acknowledge that AGR shall not be liable for any such damages.

\_\_\_\_\_ I acknowledge full and complete understanding that repairs may take longer than expected and my require a vehicle to be parked for an extended period of time on the Premises due to unforeseen, uncontrollable, or extenuating circumstances. I acknowledge that I shall not hold AGR responsible for any damages that may accrue from such unforeseen delays, including, but not limited to, damages in the form of car rental expenses, loss of business, or loss of profit resulting from not having access to my vehicle.

I hereby acknowledge that I shall defend, indemnify and hold AGR, its officers, employees and subcontractors harmless from any and all claims, liability damages, losses, expenses, fees, including attorney’s fees, costs and judgments, which may ever come to be asserted against AGR, arising out of the vehicle repairs that I have authorized herein.
